Parking Expectations:

The school has limited parking. All students are required to park in a designated area in the student parking Lot across the street from the campus. Students may also park their vehicles appropriately on Academy Way. Any student vehicle parked in the school lot **must display a valid parking pass on their rearview mirror, or risk being towed.**

In addition, the following guidelines are to be followed by all Student drivers.

- Students are to adhere to all licensing rules outlined by the Graduated Licensing Program.
- The identified vehicle must be in a safe, roadworthy condition and the student’s license must be in good standing.
- Students will drive in a safe, responsible manner at all times following all traffic laws and regulations.
- Students wishing to leave campus at lunch may do so only after signing out properly, but must return prior to the start of fourth block. They must also sign in upon returning to school.
- Student drivers will not carry passengers during the school day.
- Students must not leave campus during class hours. In special circumstances, (Doctor’s appt, family event, etc.) specific written permission signed by a parent or guardian must be provided.
- Students are not permitted to park on campus in any designated lots for parents or staff.
- A "Three Strike" Program will be enforced to ensure students follow the above noted guidelines. If a student receives three strikes , their pass will be suspended or potentially revoked.
- Passes are not to be shared with others.
- The student lot is considered ‘on school property.’ As such, the school Code of Conduct is in effect for students parked in this area.
- Pass Deposit Fees: \$20/original & \$10/replacement. Students may return their pass at the end of the year to receive their deposit back (pass must be in good condition). Students who do not return their pass by June 27 2025 forfeit the deposit paid.
